## AUGUST 282013 PUBLIC CONSULTATION MEETING SUMMARY

Approximately 150 citizens attended the public consultation meeting held last August 28th at the Community Centre. The prime purpose of the meeting was to listen the citizens' concerns. Many of them did speak out to either give comments or express concerns about the project. The promoter was present and took note of these.
The goals of the project are as follows:

- Integrate the planned changes into the current environment, while meeting the needs of the community;
- Achieve a balance between the construction of buildings and the conservation of green spaces;
- Expand our community through new residents, ensure the survival of exist-
ing businesses and be able to support new ones;
- Increase the municipal tax base and allow a better control over the tax rate;
- Make the village of North Hatley more attractive and give it a dynamic life 12 months of the year;
- Retention of the North Hatley community.
The limits of the area for the project are defined by the parking lots, rue Main and chemin Capelton. This project gives priority to three types of living accommodation: rentals, condominiums and housing for senior citizens.
Many studies have been done in the past in order to demonstrate the necessity to develop the village core. There are still many steps to be taken before the implementation of the project, one of which is the drafting of a specific development plan.
A second public consultation meeting is planned for the fall, this time with a more specific plan.

## PROGRESS REPORT ON THE FILTRATION PLANT

The work with respect to the filtration plant is progressing very well . The contractor is in the process of completing the shell and the layout work inside the building is currently under way. Slight modifications were made in the management of the construction sites with respect to connections and the expansion of the network due to budget variances, but the Régie intermunicipale des eaux Massawippi (RIEM) is confident that the goals set for the completion of the project will be met.

## PROCEDURE FOR THE REPLACEMENT OF BURNT OUT STREET LIGHTS



In order to maintain proper street lighting in the village, we would ask that you report a burnt out or flickering street light to the municipality. When contacting us, please have on hand the information posted on the Hydro-Québec pole as shown in the picture below.
A report is sent to the provider once a month in order for the repairs to be done.

## LAST 2013 BULKY WASTE PICKUP

We wish to remind you that the last bulky waste pickup for 2013 will be on October 31th.
Please take note that the following articles will not be picked up:

- Tires
- Hazardous waste (paint, batteries, oil, etc.)
- Cement products (slab, etc.)
- Refrigerator containing "Freon"


## - BUILDING MATERIALS

- Items more than 4 feet $(1.20 \mathrm{~m})$ long
- Items weighing more than 70 lbs ( 32 kg )
- No materials from a truck or trailer left at the curb will be picked up
Make sure your items are on the side of the road before the date of the collection. These must not encroach onto the public roads. It is forbidden to leave bulky waste on the side of the road after the scheduled collection dates.



## OVERNIGHT PARKING

Reflecting bylaw \# 2010-544, we wish to remind you that overnight parking is prohibited on all public roads and on the municipal parking lot during the winter season, from November 1 to April 1, between 11 p.m. and 7 a.m.

## Mrechos of the council meetings

## FEEDBACK ON COUNCIL MEETINGS OF JUNE 3, JULY 2 AND AUGUST 5, 2013.

- The "Association des commerçants de North Hatley" was a awarded a grant of $\$ 2,000$ to produce their promotional brochure on the Lake Massawippi Circuit advertising community services and the farmer's market.
- The Municipality participated in the Eastern Townships Tourism advertising campaign, for an amount of $\$ 2,500$, in order to promote the Village of North Hatley.
- The Environmental Consultative Committee (CCE) has two new members: Mrs. Paul Obermeir and Mrs. Roxane Gutzeit Godbout.
- A grant of $\$ 2,620$ was given to NHRS: $\$ 1,000$ to subsidize the summer concerts and $\$ 1,620$ to subsidize the winter maintenance of 300, rue Mill.
- A permit of occupation was issued to Transports Québec so it can proceed with some work along Route 108 to fix a drainage problem.
- Artists were given authorization to display and sell their works in Veterans Park on Saturdays and Sundays between 9:00 a.m. and 9:00 p.m. during the summer season.
- The Municipality of the Village of North Hatley authorized the payment of $\$ 673$ or $\$ 1$ per citizen to the UMQ as a contribution to the "Tragédie / Lac Mégantic 2013" fund to come to the aid of the municipality of Lac Mégantic which has suffered a disaster resulting from a railway accident.
- The second draft by-law 2013-568 amending Zoning By-law 01-432 was proposed.
- The second draft by-2013-569 amending Subdivision By-law 01-433 was proposed.
- By-law 2013-570 amending the by-law 2000-424 on site planning and architectural integration (PIIA) was adopted.


## TEMPORARY CAR SHELTERS (Abri Tempo)



Temporary car shelters are permitted from November 1st to April 15th. They must consist of a metal frame with a canvas or polyethylene cover. They must be installed on a parking spot or access road, at a minimum distance of 1.5 metres ( $5^{\prime}$ ), or 3 metres ( $9^{\prime} 9^{\prime \prime}$ ) for a corner property, from the edge of the main thoroughfare.
Car shelters must be dismantled completely and stored away out of season.

## CONSULTATIVE COMMITTEE ON URBANISM AND HERITAGE (CCUP)

Most applications for construction permits require the recommendation of the Consultative Committee on Urbanism and Heritage (CCUP). If you are planning to build or renovate, allow sufficient time for the building and environment inspector of the
municipality to look at your project (plans, sketches, etc.) and the CCUP to approve it.
To this effect, we would ask that you submit for the CCUP, at least one week prior to the next meeting date of the committee, any plan documents (placement and elevation drawings), product samples and photographs of your residence that may be required for a complete review of your project. Please note that the CCUP reserves the right to postpone a decision if it deems that additional information is required.

## LEVEL Of THE LAKE

The management of the level of the lake was delegated to the Régie du Parc régional Massawippi. The Municipality of North Hatley was appointed to be in charge of its daily operation. A committee was formed and met in August 2011 to ensure that all the factors involved in managing the level of the lake were clearly understood. This committee is comprised of the following administrators and representatives of the main users:

- Ministère de l'environnement;
- Ministère de la Faune;
- APLM;
- Recreational boater's association;
- Campingground owner's association;
- Marinas;
- Large Hôtels;
- Shoreline municipalities


At this meeting, the participants agreed that during the summer season the objective in terms of the elevation of the lake should be between 160.3 m and 160.5 m .

A second meeting with the same organisations was held in mid-June 2012. It was decided that the level targeted was satisfactory and would remain the same. The draining valve is modulated daily to attain the objective, but the lake responds a lot later so there might be some fluctuations. We must also respect a minimum ecological flow that goes downstream from the dam, that is $2 \mathrm{M} 3 / \mathrm{sec}$, to protect the aquatic life downstream. This limits our capacity to maintain the level of the lake during droughts.

## LEAF COLLECTION

This year the leaves will be collected on Fridays, October 25th, November $1^{\text {st }}$ and November $8^{\text {th }}$.


Remember: Your bags must be on the side of road by 7:00 a.m. the morning of the collection.
Please take the following steps to ensure that your leaves are picked up.

- The leaves must be put in compostable paper bags - no biodegradable bags will be picked up;
- No plastic bags will be picked up;
- The bags must not contain pine or fir needles nor any other type of waste;
- The bags must be put on the side of the road preferably the night before the collection which will be done on the Friday in the morning.
We wish to remind you that, should you miss the collection dates, you have two other alternatives offered to you for the recycling of your dead leaves:

1. Shred small amounts of leaves with your lawn mower; these will serve as excellent fertilizer.
2. Put them in your brown bin (compostable matter).

August 3-4 was the annual Garage / Rummage Sale at the Pleasant View Beach house. Pictured above are 21 of over 60 volunteers who helped with the sale. Thursday was the collection of items and Friday the volunteers priced the items ready for the sale. By 9am. Sat., there were over 100 people lined up waiting for our doors to open.

Record sales this year produced a profit of $\$ 5,400$ which will be used for NHRS projects. This year for example we bought 8 Adirondack chairs, a set of patio furniture, a new soccer table, and a new ping pong table, etc. for a total value of $\$ 4,000$.
These purchases would not be possible without the volunteer help and donations from the community.

## PEDESTRIANS, BE SAFETY CONSCIOUS!



The Highway Safety Code provides regulations to make walking safe. Don't take chances, be safety conscious.

## On the sidewalk :

Walk on the sidewalk. If there is none, walk on the shoulder or edge of the road, facing oncoming traffic.

## Before you cross :

- Go to the nearest intersection or the pedestrian crosswalk enclosed within yellow pavement markings;

- Take a moment to check the traffic to make sure you can walk across safely:
- Look left, right, then left again;
- Look over your shoulder to check that no vehicles are coming from behind;
- Establish eye contact with drivers to make sure they see you.


Don't forget that heavy vehicles represent a particular danger to pedestrians because some zones, behind and on each side of the vehicle, are invisible to the driver; who therefore cannot see any pedestrian who may be there. Wearing headphones
makes pedestrians vulnerable to accidents because they don't hear traffic noise. Light-coloured clothing or garments with reflective bands will make pedestrians more visible.

## DRIVERS, YIELD THE RIGHT OF WAY TO PEDESTRIANS!

Given their exposure to being struck by a vehicle, you must grant pedestrians extra consideration, particularly at intersections and at pedestrian crosswalks.

## AVOID DOG BITES... BE SAFE RATHER THAN SORRY

Most people consider their dog an integral part of their family, so everyone is surprised when the dog bites. How could Fido do this? A dog never bites without a reason even if, for the human, the dog's
 reaction to a situation may be incomprehensible.
Dogs communicate with humans; for your own safety and that of others, it is important that you understand the dog's language. For example, if a dog begins to growl when you approach it, never reprimand it, because this growl constitutes a message; the dog is simply telling you that it is not comfortable in the current situation. If you reprimand it, it could bite without further warning.
According to the statistics, family dogs are most likely to bite someone close to them; bites from wandering dogs are possible, but very rare. It is the children who are most vulnerable. You must therefore teach your children the following essential rules: never 1) approach a dog you don't know, particu-
larly if it is tied up; 2) put your face close to a dog's face; 3) look a dog you don't know in the eyes; 4) hurt a dog; 5) shout or make sudden moves in the presence of a dog. Also remember most dogs do not like to be picked up or held. As a parent, you should never leave a child under 7 years of age alone with a dog; accidents happen so fast.


As for adults, never forget that any dog can bite and this does not mean that dogs are not good companions. A dog may bite if it is in pain, scared or angry.


Lastly, you may think a dog will learn to be less protective of its food if you play in his bowl while it is eating. Think again! The opposite will happen; your dog will learn to distrust you when you approach while it is eating and it could eventually bite you. It is better to leave it alone while it is eating.
