THAT the preamble to this resolution is an integral part of it as if it were reproduced here in full;

THAT the borrowing, by issue of notes, of the amount of \$1,486,900 as provided under borrowing by-law numbers 2004 479 and 2007 515 be carried out;

THAT the notes be signed by the mayor and the secretary-treasurer;

THAT the notes be dated September 9, 2014;

THAT the interest on the notes be paid semi-annually;

THAT the notes, with respect to the capital, be repaid as follows:
