TAKE NOTE THAT

- the application for entry or the power of attorney sent after the tabling of the list of electors, but not later than will be considered an application to amend the list of electors.
- every elector entered on the list of electors in another capacity than that of domiciled person and who makes an application therefor in writing can vote by mail;
- every written application to vote by mail must be received at the office of the returning officer not later than the last day set to submit an application to the board of revisors, namely on

A model application for entry or power of attorney form, including the application to vote by mail, is available at the office of the returning officer. These documents take effect when they are received and remain valid until such time as they are withdrawn or replaced or unless the municipality cancels the resolution stipulating that every elector entered on a list of electors in a capacity other than that of domiciled person can vote by mail.
