PAUL ST-PIERRE	Q	Independently of any decision by the Quebec Government, and given the size of even a reduced project (10 to 15 times the size of the new Connaught), do you continue to support building the condo project in the flood zone in the middle of town? [Indépendamment d'une décision éventuelle du Gouvernement de Québec, et étant donné la taille du projet, même réduit (de 10 à 15 fois la taille du nouveau Connaught), est-ce que vous continuez à appuyer la construction du projet de condos dans la zone inondable dans le centre du village?]		
	R	Council cannot express its views on hypotheses.		
PAUL ST-PIERRE	Q	Is a 'cocktail deck' on the rooftop (near School street) being planned for the Connaught? Was it approved in the original plans presented to the CCUP, to Council and to the public? Is such a deck allowed by the existing by-laws of the Town?		
	R	The 'cocktail deck' was not part of the original plans. Our municipal inspector will look into the issue with the Connaught project developer.		
PAUL ST-PIERRE	Q	Has the resignation of Richard Gourde from the CCUP previously presented as temporary been made permanent?		
	R	Once the contract linking M. Gourde to the Municipality has ended, he will be able to join the CCUP again if he so wishes.		
PAUL ST-PIERRE	Q	Does the calculation in taxes presented on the town's website (see Tax Cost Estimation for 2021) include the expected increase in the valuation roll (estimated, according to your figures, at 6,33% for 2021)? Won't the average house valuation increase by 6,33% (from \$342,200 to \$363, 648) with a subsequent average tax increase of \$432,81 (instead of the \$85,17)?		
	R	Not all homes have seen an average increase of 6.33 %. Some residences have decreased in value while some have increased by a larger percentage. Estimates on same values as in past years allows for sound fiscal effort.		
Q PAUL ST-PIERRE	Q	In September 2020 the mayor affirmed the six-wheel trucks were used to plow "all the streets of Municipality" (see the minutes for his response). If such is the case, why then have snowplows been bought for the two new pickup trucks? Are they needed to plow the streets in addition to the six-wheel trucks?		
	R	With the bridge reconstruction, we must have vehicles on both sides of the bridge. Because of the little precipitation we've had so far, only one plough has been needed. The other is presently on backup if needed due to equipment breakdown.		
DON WATT	Many municipalities in Quebec have organized the administration of the flu vaccines for the 2020- 2021 winter session using their facilities . Is North Hatley arranging and offering their facilities for the vaccination of our 400 citizens for the Corvid-19 vaccine slated for this spring ?			
	R	If not, is it up to each citizen to arrange this on their own ? Public Health and the CIUSSS de l'Estrie-CHUS will determine the locations for vaccination.		
DON WATT	Q	Since the Quebec government has not yet clarified their clear approval of new government flood zone residential construction, is this project still considered as an acceptable planned project for our community ?		
	R	Council has stated its openness to a project at the heart of the village. We are awaiting directives from the government of Quebec regarding the floodzone.		

	Q	Where can one find a definition of the DNA of the village?
MICHEL DESROSIERS	R	Although we don't have an official definition of the DNA for the village, it has been defined based on the characteristics enunciated by the citizens of the village in the strategic planning. They have as such been compiled in the document as characteristics that stood out in public consultations.
MICHEL DESROSIERS	Q	Despite awaiting an acceptance or refusal from the ministry of the environment, the Municipality must already have a plan, ideas. Sharing them with the citizens would be much appreciated.
	R	Within the framework of strategic planning, the Municipality held public consultations on the future of the Village, including development. Work by the designated committee is ongoing. Council will present the strategic plan once it has been completed.
MICHAEL GRAYSON	Q	Firstly, I would like to know if it is true that the Town has no power to refuse permission for cutting of trees. If this is so, I would like answers to the following questions: Why has the Town not revealed its inability or unwillingness to
		protect trees over the last decade? Why has the Town continued to go through the motions of requiring tree-cutting permits, when in fact it cannot refuse them?
		MOST IMPORTANT: Does the Town have the intention of treating this issue with urgency and bringing back tree protection bylaws?
	R	As mentioned in a message from the Mayor at a previous meeting, a draft regulation will be presented shortly to better regulate the cutting/preservation of the forest cover on the territory.
