RESIDENTS		ISSUES
	Q.	By-law 2022-652 Should a private enterprise or person ever be allowed to use a public beach or any other public space in North Hatley (such as River Park, Dreamland Park, Memorial Park, the ball park, the public beach, etc), whether the use is temporary or permanent? That is the question raised by the Council-approved private use of the public beach at October's meeting and by the proposed new by- law (2022-652), which foresees both types of use (permanent or temporary) of all public spaces of North Hatley (roadways but also parks), even by non-residents. This is the thin edge of the wedge, with serious implications for residents. Will public access to the ENTIRE public spaces (parks) continue (public access to the public beach was guaranteed by the mayor in an answer to Dominique Cyr at October's Council meeting). Parks should not be included in this by-law. I would never have given land in Dreamland Park to the Town if this by- law was being envisaged, nor would other donors for other parks I dare say.
PAUL ST-PIERRE	R.	Two part answer. As for the sauna at the beach, we agree that it's not the ideal situation, but we feel ok with approving the project. It's certainly not a permanent fixture. Although it was eventually approved, the council debated on this subject for a long time due to the comments and concerns we received about the winter months, and how businesses seem to suffer, and we have nothing to do in town other then watch the snowflakes fall. The goal of this project was to test the waters without committing to anything. So no, it's not the ideal situation, but within the possibilities that we looked at, this was the best fit. As far as the parks and allowing use, we didn't have proper by-laws in place before to stop people from using the parks. This summer, when the Jehovah Witnesses' were in the park, we sent the inspector multiple times, but we didn't really have anything that could make them leave. With this adoption of by-law, anyone that wants to use the parks for activities, will need to submit their request to council and get approved. We understand

		your concerns, and we have them too, but the point is to protect the parks.
	Q.	By-law 2022-651: Is the zoning modification involving zone P-7 (zone including the school, and the parking lot on School Street) in relation to a particular project? If so, what is this project? If not, why propose a change in zoning, when no other zone marked 'P' accepts institutions? Why is the public consultation being held only AFTER adoption of the by-law? Why is this change not being submitted to a vote?
PAUL ST-PIERRE		Yes it is a direct result of a project that is proposed to council. The Greenhouse project. A unit that will house a maximum of 12 seniors that do not have full autonomy anymore. They're now in the process of working on their business plan. They needed the zoning to be modified in order to build and continue their project. We did the notice of motion in September. On October 4 th we passed a resolution adopting the first project of the by-law and announced the public consultation which was to be held tonight at 4p.m. Noone attended, but we did follow the procedure.
PAUL ST-PIERRE	Q.	By-law 2022-653: The proposed by-law 2022-653 would allow the center of the Town (zones C) to be swamped with 20 Auberges or Inns, 22 Gîtes touristiques (vacation rentals, such as airbnbs) and 24 Maisons de tourisme (bed and breakfasts) or a total of 66 hotel-like accommodations (without indicating how many rooms this potentially involves, and how much private parking is available?). Is this the desire of the inhabitants of this village? It should be noted that the proposed by-law was not yet available for public consultation on November 4, contrary to the spirit of paragraph 3 of article 455 of the Municipal Code of Quebec, which allows for public scrutiny of by- laws proposed by Council.
	R.	This is a first draft. As we will cover later in item 13, there will be public consultations.
PAUL ST-PIERRE	Q.	Why is Nathalie Meunier's name included as an alternate mayor at October's Council meeting (unanimous resolution 2202-10-04.10), when her resignation from Council was approved earlier at the same meeting? Her name still (November 5) figures on the Town website as a Councillor.
	R.	She was included in the resolution because she was still on council when she was pro-mayor. For the website, the administration actually went in today and removed her so that the information is up to date.

		Q	UESTIONS SENT BY EMAIL		
		Q.	The noise and speeding continues on Sherbrooke Road (this is dated November 5). When will something be done about this (good intentions, without concrete results, are not enough, as the problem continues one year after the present Council was elected to office)? The problem is compounded by illegal parking on the street.		
	PAUL ST-PIERRE	R.	We are aware that the traffic in this town is a serious issue, between noise and speed. The stop signs that we have put in place, are going to stay. We are examining with the council to see what more we can do to get a message to people to think twice about their driving. We have also spoken with the SQ and we have now three possible dates for a meeting with the population to answer any questions you might have.		
		Q.	When will the taxpayers be invited to the council planning meetings?		
	DON WATT	R.	I'm happy to tell you that at our working meeting at the end of January, we will discuss how a document will be sent out, anyone that wants to voice concern or be heard about a certain topic on the agenda will be able too. One hour will be attributed to the public at the working meetings.		
	DON WATT	Q.	With respect to the meeting agenda, published before the meeting, could more detail be included as seldom is sufficient detail offered to understand even the point of having the item on the agenda.		
		R.	We had started doing that as an extra service. Although not necessary, we believe it's a practice that is helpful and we received a lot of good feedback. Due to technical issues, we were unable to include little resumes in the Agenda for this month.		
	MIKE MUNKITTRRICK	Q.	As a former member of the fire department for 30 years, I was disappointed and embarrassed that nobody from the fire department was present at the		



			remembrance day ceremony and I was wondering if
			council had an explanation.
		R.	I received a phone call at 11h30 on Sunday morning at home asking if I had access to barricades. We went down ourselves and found some on Massawippi and installed them on School and Main. The fire department wasn't notified by the legion and we didn't get a request either. I think it was forgotten by them, there seems to have been a lack of communication for the ceremony this year between the Legion and the Régie as well as us. There was no one to watch the barricades.
			Resident for 50 years, I have 2 subjects.
			First, Blue Massawippi. Second, connection with transparency of municipal council with regard to the first subject.
		Q.	I live on the river and am very aware as to what the season has been like. I have heard a lot of complaints concerning Blue Massawippi. We have students who were supposed to be on the job. It was very difficult for the operators of the Marina to operate properly cause they didn't have a key to open the gate. I heard stories that people would go out in their boats and come back and the gate was closed. There were incidents where students couldn't produce the receipts.
	DAVID CAMPBELL		In the past, North Hatley had a washing machine operated by the Marina staff, and to my knowledge has worked out very well. In addition, I understand that the municipality has bought new equipment. I want to ask the council as to what your experience is with Blue Massawippi, because to us it seems like a disaster.
		R.	I will say that it was not fun for anyone this summer. There were definitely problems with Blue Massawippi. We were faced with making a decision because of the Zebra Mussels. For years, North Hatley has been blamed for the problem.
			Now the relationship between certain individuals wasn't the best and we received complaints also. I agree that it was not ideal. We got more receipts printed by the MRC when we ran out. We know it wasn't perfect. Considering the crisis we're in with the lake, our municipality tried it's best.
			As far as the washing station, we did purchase a new one and received it at the end of the season. It has been winterized and properly covered for next season.
	DAVID CAMPBELL	Q.	Governments and transparency of council. Your working meetings go on for about 5 hours. Do you have resolutions for your attendees. Is there any official protocol?
		R.	There is no official documentations from our meetings. The working meetings are to discuss, not pass anything. We build the resolutions for the council meeting from these discussions.
		Q.	Can all of these zoning changes be sent through infolettre so that we are aware of the changes?
	MICHAEL GRAYSON	R.	Yes. We can put something together to make it simple for people to understand what changes have been made. These are big dossiers at the moment, once they've been closed, we'll be able to produce that.
		Q.	Did the council members see the contract for ??
	CARLE HALLER	R.	No. The contract was made by the administration. I took the comments and suggestions from council when we

		discussed it and helped put together the contract.
	Q.	I wonder if Zebra mussels could be found on the bridge or the barge. Has anyone thought to check these places?
CAROLE HALLER	R.	It's too late now to figure out where and how they came in. It could've come from anywhere, the problem now is that it's here.
	Q.	The remembrance day ceremony was disappointing for sure. However, I was told that the Legion called the municipality twice and didn't get a call back.
CAROLE HALLER	R.	They called me Sunday and literally said 'they forgot'. No one called the town hall. If they do not leave a message, how are we supposed to know to call them back.
	Q.	When are we getting the "welcome to North Hatley" signs back?
??	R.	It's been added to the budget this year because the ones we did have got damaged and that's why they came down. The last council looked at replacing them, but the prices were ridiculous. Alan can't do it because he's married to me but we're looking at getting them changed.
		The one in the center of Town was graciously donated by Alan.
??	Q.	Where does North Hatley start on the way out to Katevale?
	R.	Just passed Hovey Manor's driveway.
